TOP TIPS

BE STRATEGIC

Showcase your organisation's strategic prowess, emphasising innovative approaches and forward-thinking initiatives to leave a lasting impression. Focus on what the criteria actually asks for and ensure you supply relevant information.

BE INSPIRING

Weave a compelling story that highlights your organisation's inspirational journey, as well as the passion that sets you apart from others candidates.

BE IMPACTFUL

Underline the lasting impact of your initiative on the waste and recycling sector by highlighting the details of its contributions. Make sure the entry is well written and kept to the word count.

BE HONEST

Sadly we can't just take your word for it that you are brilliant! You need to give hard evidence that backs up the detail of your entry, including results, or benefits to the wider community.

THE CATEGORIES

INDEPENDENT BUSINESS OF THE YEAR

This award aims to recognise the work done by a recycling company, small or large, operating in the UK, which has provided a service in a consistent and thorough way for its customers.

AI OR TECHNOLOGY OF THE YEAR

This category looks to recognise cutting-edge innovations in AI and technology that have significantly advanced the recycling industry. Entrants should demonstrate solutions that have improved the efficiency, accuracy and scalability of recycling processes, from sorting and processing to resource recovery.

EXCELLENCE IN ENVIRONMENTAL IMPACT

This award celebrates leaders setting new benchmarks in environmental stewardship and driving a more sustainable future.

SOCIAL VALUE WITHIN A COMMUNITY

This award recognises outstanding initiatives by local authorities, organisations or teams that have delivered significant social value through their waste and recycling activities.

NEW

BEST NEWCOMER OF THE YEAR

The award celebrates promising new entrants in the waste management, recycling, and environmental sector who demonstrate exceptional innovation, impact and potential for future success.

NEW

WASTE MANAGEMENT INITIATIVE IN THE RETAIL, COMMERCIAL AND PUBLIC SECTOR

Entrants can show how this has helped their company or organisations performance or improved the service they offer in terms of sustainable waste management. For larger firms, entries can be made for recycling achievements within divisions or specific operating sites. Please note, this category is not open to local authorities or retail firms.

ENERGY INITIATIVE OF THE YEAR

This award celebrates a standout project that has delivered exceptional results in energy efficiency, renewable energy integration or energy recovery within the recycling and waste management sector. Entries should highlight measurable.

NEW

SUSTAINABLE PACKAGING INNOVATION

This category recognises organisations, teams or projects that have excelled in creating or implementing innovative solutions for sustainable packaging.

NEW

CIRCULAR ECONOMY SUCCESS

This award will be presented to the business, local authority or organisation which can show how it has provided for success within the circular economy process in the waste management and recycling sector. Judges will take a flexible and broad approach in assessing this potentially wide-ranging category.

NEW

THE CATEGORIES

INNOVATION OF THE YEAR

This award aims to recognise the work done by a metal's recycling company, small or large operating in the UK which has provided a service in a consistent and thorough way for its customers.

COLLECTION CREW OF THE YEAR

This award will recognise the dedication and high-level of service provided by a collection crew involved in either waste collection, recycling or both.

HEALTH & SAFETY INITIATIVE OF THE YEAR

This award will recognise an initiative to raise health and safety standards within a waste management or recycling business, or in a relevant local authority division. It can be for a large scale-project or one that just impacts a niche area of activity, or a few individuals.

THE BEST LOCAL AUTHORITY RECYCLING INITIATIVE

The award is targeted at an initiative in the municipal waste stream and will recognise a project developed and delivered by a local authority which indirectly or directly helps to promote one or more of greater recycling, composting, sustainability and waste prevention.

CONTRIBUTION TO TACKLING NET ZERO

Net-zero goals have never been more in focus. In a year of action this award is looking for examples of how businesses, organisations and local authorities have been implementing clear and circular economy goals in their work. This may include developing new and successful strategies towards carbon neutrality or carbon reduction.

LOCAL AUTHORITY INDIVIDUAL OR TEAM OF THE YEAR

This will be given to the local authority officer, councillor, leader or team at a local authority, waste partnership or similar body which has achieved a high level of success in driving up recycling rates and/or shown success in other areas such as reuse rates, communication, leadership, education and sustainability.

SERVICE CHANGE AT A LOCAL AUTHORITY LEVEL

This category is for local authorities and will involve recognition of a successful service change in part or all of the council area for residents or local businesses. This category will also include service change in waste partnership areas and where councils have a cross-boundary working structure.

REUSE INITIATIVE OF THE YEAR

Entries should include testimonials from key stakeholders, community members or partners who have experienced the positive effects of the reuse initiative. These testimonials should emphasise the real-world impact and credibility of the initiative.

CAMPAIGN OF THE YEAR

Enter your waste and recycling campaign for a chance to be recognised as the Campaign of the Year. Provide a brief overview of your campaign's objectives, target audience and innovative approach. Highlight measurable impact, audience engagement, multichannel integration and any collaborations that contributed to the campaign's success.

THE CATEGORIES

FOOD WASTE INITIATIVE OF THE YEAR

This category looks to recognise organisation that has undertaken an initiative in tackling food waste through prevention, reduction, reuse and recycling. The award celebrates innovative strategies and impactful programs that have successfully minimised food waste across the value chain, whether this be from production to consumption.

RESOURCE & WASTE MANAGEMENT PARTNERSHIP OF THE YEAR


